



FAN CLUB - STATUTE

1. Name and headquarters

Under the name "Fan Club Sales Inglin" there is a club (not an association in the sense of Article 60 ff. CC) based in Rümplang / ZH.

2. Purpose and objectives

The club aims to support the sporting career of Sales Inglin, born 27.08.1999, as well as the promotion and maintenance of the companionship of the club members.

3. Resources

To pursue the purpose, the Fan Club annually levies a membership fee. The amount of the membership fee shall be determined by the board of directors. The club can also accept all kinds of donations.

4. Membership

The Fan Club Sales Inglin consists of members and sponsors. A member is who paid the annual membership fee.

Members who financially support Sales Inglin in addition to the fan club membership are referred to as sponsors. The difference to the membership fee goes to Sales Inglin.

Members and sponsors of the fan club can be natural and legal persons.

The members of the fan club benefit from all the services and offers the members of the fan club board provide to the members. These include the invitation to an annual fan club, the organization of trips to competitions, the submission or discounted delivery of fan club articles, etc.

Newcomers will receive a Sales Inglin Fan Club shirt as a welcome gift.

6. Termination of membership

If the annual contribution is no longer paid, the membership will be terminated.

A member can be excluded from the fan club at any time and without a reason by unanimous decision of the board of trustees.

7. Board of Directors

The Sales Inglin Fan Club is managed by the Fan Club Board of Directors. The management of the fan club is composed as follows:

- A) President
- B) Vice President
- C) Actuary
- D) Cashier
- E) Material maintenance
- F) Communication

The Board of Directors of the Fan Club is self-constituting and elects any successors when leaving the Executive Board. A single person can accept and represent multiple functions.

The Board of Directors of the Fan Club ensures that the club management is always able to act and the positions are fully staffed.

The tasks of the individual members of the Fan Club Board are as follows:

- President: The president directs the fan club and represents the club to the outside. He calls the meetings of the Board of Directors and has the casting vote in case of a tie.
- Vice President: The Vice President assumes the duties of the President in the event of a hindrance.
- Actuary: The actuary is responsible for the written correspondence and draws up the minutes of meetings of the Board of Directors. He is also responsible for the media reports, but can also delegate this to a third person.
- Cashier: The cashier keeps records of the receipts and expenses of the Fan Club. He shall charge the membership fees and shall fix the financial obligations of the Fan Club, in consultation with the Fan Club's Board of Directors. The cashier also performs the members' control. This is to be kept up-to-date at all times. Every year he submits the annual accounts to the Fan Club's Board for approval.

Material maintenance: The material manager manages and ensures a perfect condition of the club's material (flags, panels, fan articles, etc.) at all times. He is responsible for shipping the fan articles. He manages the stock of inventory, checks the inventory, and maintains an inventory list. In consultation with the Board, he manages purchases of the various consumables.

Communication: The communication officer supervises and maintains the fan club activities on the internet (Facebook, Instagram, website).

8. Representation

The Board of the Fan Club represents the club externally and conducts the current business. The board can designate assistants who can also represent the Fan Club for the outside (for example media supervisors, etc.).

9. Liability

Only the assets of the Sales Inglin Fan Club shall be liable for the liabilities of the Club. The Board of Fan Club is prohibited from making debts or borrowing loans. Otherwise, the members of the Board of Directors shall be liable for claims arising therefrom without restriction, in a personal and solid manner.

The Club declines any liability for the trips it organizes to competitions and events. The club members are responsible for sufficient insurance protection on trips and occasions themselves.

10. Statute changes

The current statute may be modified at the suggestion of the members or the Board of the Fan Club. The Board of Directors finally decides on any changes to the statutes. It requires unanimity.

11. Termination

The Fan Club will be dissolved after Sales Inglin's sports career has ended and the club's purpose in the narrow sense is thus fulfilled. Any fortune is attributable to a youth sport organization in athletics.

12. Legal validity

These statutes have been approved at today's meeting of the Board of Fan Club and will enter into force on this date.
